This season opens our 12th year in the business of growing and selling

nursery trees.

We were in the nursery business in Orange county ten years, and this season marks our third crop of trees in our present location. We chose this spot with a conviction that it would prove a superior environment in which to grow trees, and if you will visit our nurseries we think that you will agree our judgment was sound.

We are in the northeast corner of Simi Valley, on a mesa 1100 feet elevation, with a south exposure, sheltered from the coast by a fine range of rugged hills, with a lime-charged soil that is practically limitless in fertility and depth.

We do not claim a large nursery, about 150,000 trees and vines, but we do claim quality second to none.

In our present location we have grown mostly grafted walnuts, but this season have in addition the varities listed below and next season will have all varities of our own growing.

Last season, so far as we are informed, every walnut tree planted in our valley was grown in our nurseries, and were also planted from Santa Ana to Ventura.
